- 2. Shares of common stock are held directly by 5AM Ventures V, L.P. ("Ventures V"). 5AM Partners V, LLC ("Partners V") is the sole general partner of Ventures V. Dr. Parmar is a managing member of Partners V and may be deemed to share voting and investment power over the shares held by Ventures V. Dr. Parmar disclaims beneficial ownership of the shares held by Ventures V except to the extent of his pecuniary interest therein.
- 3. The option vests as to the underlying shares of Common Stock on the earlier of July 28, 2022 and the date of the first annual meeting of stockholders of the Issuer following the closing of its initial public offering.
